#### Good Afternoon,

On October 14, 2020, the California Department of Public Health (CDPH) issued an update regarding the *Guidance* on *Schools and School-Based Programs* originally released on August 3, 2020. The update stated that "outdoor singing and band practice are permitted provided that precautions such as physical distancing and mask wearing are implemented to the maximum extent possible." Following the announcement, SVUSD vocal music students resumed instruction with the following safety protocols in place:

- All students are screened prior to rehearsal, including temperature and symptoms check
- Rehearsals/classes occur outdoors, with at least 6 feet of physical distancing at all times
- Students always wear facial coverings while singing

However, since the update also stated that the "playing of wind instruments (any instrument played by the mouth, such as a trumpet or clarinet) is strongly discouraged," in-person rehearsals have been delayed. Since then, SVUSD has developed the following safety protocols to limit the spread of COVID-19, and to allow for wind instruments to be played at school at this time:

- All musicians will be screened prior to rehearsal, including temperature and symptoms check
- Rehearsals/classes will occur outdoors, with at least 12 feet of physical distancing at all times
- The following Personal Protective Equipment (PPE) provided by SVUSD will be required for wind instruments and musicians, and must be used at all times:
  - Flute shields
  - Bell covers
  - Musician's face coverings
- Practice time limits will be followed, with a 5 minute break following 30 minutes of playing time to allow for aerosols to disperse
- Small group cohorts limited to 5-10 students
- No shared equipment (instruments, music stands, music) between students

While we are pleased to share this update with you, we must also share that participation in these activities may generate increased aerosols and may pose a greater risk of contracting COVID-19 according to the <a href="International Coalition of Performing Arts Aerosol Study">International Coalition of Performing Arts Aerosol Study</a>. Based upon this study and the recent move to the most restrictive (purple) tier,, we are asking you to complete the <a href="Athletic/Co-Curricular Assumption of Risk">Athletic/Co-Curricular Assumption of Risk</a> waiver indicating your acknowledgement of the potential increased risks of singing and playing wind instruments outdoors at school during COVID-19. Your music teachers will be collecting the waivers directly and will be planning learning activities for our students according to the protocols outlined above.

We appreciate your patience in awaiting this update as well as your advocacy in support of our programs. Should you have any questions, please contact your student's music teachers directly.

We agree, here and forever, to the maximum extent permitted by law, for ourselves, our family, our heirs, personal representative(s), and/or assigns, to defend, hold harmless, indemnify, discharge, release, and covenant not to sue SVUSD, its Board members, administrators, officers, agents, employees, volunteers, representatives, and other individuals acting on its behalf, from and against any and all liabilities, claims, demands, actions, or causes of action of any sort, present or future, on account of damage to personal property, or personal injury, or illness, or death which may result from student's participation in the activity, including but not limited to that arising out of exposure to or infection by COVID-19. This release specifically includes claims based on the negligence of SVUSD, its Board members, administrators, officers, agents, employees, volunteers, representatives, and other individuals acting on its behalf. This release applies whether a COVID-19 infection or related illness occurs before, during or after a student's participation in Athletics and Other Co-Curricular Activities. We understand that we are releasing claims and giving up substantial rights, including our right to sue, and are doing so voluntarily. No representations, statements, or inducements, oral or written, apart from the foregoing written statement, have been made.
